



DIPLOMA IN **APPLIED FINANCIAL TECHNOLOGY**

Financial Technology (FinTech) is a broad but rapidly-evolving area, covering new predictive analytics methodologies, financial optimization, cyber-currencies, data-driven risk methodologies, cyber-security in finance, new distribution technologies (e.g. blockchain), high-frequency trading methods, and machine applications in finance including the insurance industries.

This program is for foreign and domestic students with (or soon to receive) a bachelor's or master's degree, with some strength in the mathematical sciences, looking to expand their horizons in FinTech.

Students take classes at MIM, 2 Washington Street, New York, NY, and carry out their internship in New York City. Upon satisfactory completion of the program, students will receive the corresponding Manhattan Institute of Management "Diploma in Applied Financial Technology" certificate of completion.

MIM INTERNSHIP PROGRAMS on J-1 Visa

*THE MIM INTERNSHIP PROGRAMS ARE REFERRED TO AS ACADEMIC TRAINING FOR J-1 VISA STUDENTS.

The MIM internship programs' objective is to provide its students with the opportunity to apply the principles and theories that they have learned in the classroom to a professional environment. We view it as a learning experience that integrates academic knowledge with practical application in a real-life setting. We believe that Internships will help our students gain valuable experience, acquire critical skills, and make connections in professional fields in which they are considering future career paths.

What you can achieve during your internship program of academic training:

- Learn new skills such as communication and teamwork for group work as well as technical skills for individual work
- Gain industry knowledge first-hand from an organization and its staff
- Meet new people and develop networking skills
- Acquire valuable experience to add to your resume for future job search
- Receive regular, detailed, and measurable feedback on your performance to give you direction during your internship

Internship Program Structure

MIM offers four internship programs that are designed to meet the needs of students with different levels of academic coursework and experience.

- Three of them follow the completion of the academic component of each MIM academic program: 3 months, 6 months or 9 months
- One of them, the Master Internship is a stand-alone program (see following page).





MASTER INTERNSHIP PROGRAM ON J-1 VISA

This extended internship program is available to students:

- who are completing or have recently completed their master's degree at a School, College or University in the USA or abroad; for example, students of Business Schools or IT or Engineering schools who want or need to do an internship during or after their program
- who are looking to have a one-year professional experience in a company in the field of their choice in New York.

Students will be assisted by Human Resources professionals at MIM who will help them in the process of presenting their candidacy and obtaining interviews, including:

- Writing the best possible resume and cover letter
- Preparing for face-to-face interviews via Skype or in person

Upon completion of this extended internship, students will have considerably improved their professional skills and will be ready for full-time employment in their chosen industry or function
